Greetings from the Vice President



Prairyerth's 2nd Annual living Treasures of North America Heritage Awards

— Honoring Ray Schulenberg & Jim Gillihan — April 15, 2000 at the Unitarian Church of Evanston

Last year two Native Grandmothers in their eighties were honored as "Living Treasures." This year the designation goes to two men for their lifelong commitment to bringing people into harmony with the Earth and restoring health to all. The \$55 registration for the day includes continental breakfast, lunch and workshops. Registration begins at 8:30 a.m., with the Opening Ceremony at 9:30 a.m., followed by morning workshops, lunch and the afternoon honoring program of stories about the lives of Ray Schulenberg and Jim Gillihan interspersed with music of UU Troubadour Jim Scott, presentations and responses. The Closing will be a pipe ceremony led by Jim Gillihan. Vendors will be present. The followong eight workshops are planned:

- * Our Generation: Roots and Wings, two men on growing up Indian in contemporary America
- * Songs for the Earth, with our featured singer/songwriter
- * Earth Rhythms: African Hand Drums
- * Eat Your Weeds, on edible plants in the urban/suburban yard
- * Herbs of Our Elders, an herbalist shares her knowledge of the healing properties of common plants
- * Healing Predators/Restoring the Earth, a wildlife rehabber/educator, with her kestrel, explaining the importance of predator birds to a balanced eco-system
- * The Return of Navaho Boy, a filmmaker showing and discussing his Sundance Film Festival hit
- * Effects of Genetically Engineered Plants on the Bio-Sphere, a forum

James Gillihan

James Gillihan, a highly respected man of Cherokee heritage, was made the fourth Keeper of Sitting Bull's Pipe in 1978 by Fool's Crow of the Lakota Nation. Although trained as an archeologist, Jim worked on Illinois and Missouri road crews as he became uneasy about the destruction of Native burial grounds. He has served as director the Natural History Museum of the University of South Dakota, Cultural Preservation Director for the state of South Dakota and as the governor's liaison to the traditional Lakota People.

Jim currently serves on the Indiana Native American Council. Refusing to take any recompense for his healing work with Sitting Bull's Pipe, Jim supports his wife and son as an antique and fine arts appraiser. In 1998, Jim was recognized as a Spiritual Leader by the Prairyerth Unitarian Universalist Fellowship.

Ray Schulenberg

Ray acquired his love of plants from his mother on a 120-acre Nebraska farm. During college he began learning the Sioux language, which led to work with the Indian Service and visits with Blackfoot, Mandan and Hidatsa tribes. A 20-acre plot on the Iowa Reservation in Nebraska was his first effort to try to heal the wounded land. (Years later Ray added 264 adjoining acres and donated the entire restoration to the Nature Conservancy.) After earning a BS in Horticulture at the age of 34, Ray became Curator of Native Plants at the Morton Arboretum in Lisle, Illinois. Pioneering many techniques of prairie planting, he restored 55 acres of farmland into native prairie, the Schulenberg Prairie. Ray considers his final 10 years at the Arboretum as Curator of the Woody Plant Collection his greatest contribution. He rehabilitated the collection, improving an already prestigious collection, making it as correct, complete, meaningful and accessible as possible.


RCRC (Religious Coalition for Reproductive Choice) in Illinois has taken an opportunity to counter some of the extremist "anti" advertising in McHenry County with the above info on a billboard. ... and another one can be found in Springfield, for our legislators to see. On that front, RCRC, Planned Parenthood, YWCA, AAUW, ACLU, League of Women Voters and many other concerned groups are strongly supporting Illinois HB3201. Currently the Sexual Assault Survivors Emergency Treatment Act only requires a hospital to provide written and oral information concerning the possibility of pregnancy resulting from sexual assault. It does not require hospitals to inform a rape victim about emergeny contraception or provide the medication if it is requested. HB3201 would require all hospitals that provide emergency services to sexual assault victims to provide that information and emergency contraception (most commonly a special dose of ordinary contraceptive pills taken within 72 hours of intercourse).

HB3201 passed the House by 76-42 and is stuck in the Senate Rules Committee. We need to contact our local Senators to urge getting it released to the floor of the Senate, where it is felt it has a decent chance of passing. Email barrages are NOT seen as effective methods of lobbying, but letters are. Accessing the web site www.pro-choiceillinois.com can help you bridge the gap between the computer and your legislator's mailbox. Through that web site, a hard-copy letter will be generated and delivered to the designated person. Be sure to visit the site, as there's a <u>lot</u> more to it. If you're in/near Springfield and would like to help with RCRC's work, they'd love to hear from you. Call them at 773.509.6374.

Another RCRC/Planned Parenthood event held on February 16th was a half-day consultation, "On the

Forefront of Faith and Sexuality," to which clergy from many denominations were invited, held at the UU Church in Oak Park. Sessions featured the following topics: new developments in reproductive health that have implications for faith and ministry; curricular and pastoral materials for congregational use on sexuality and reproductive health; briefings on the impact of hospital mergers on health care; and information on legislative initiatives that serve victims of rape and incest. There will also be a presentation by Debra Haffner, President of SIECUS (the Sexuality Information and Education Council of the United States).
